## LOCATION

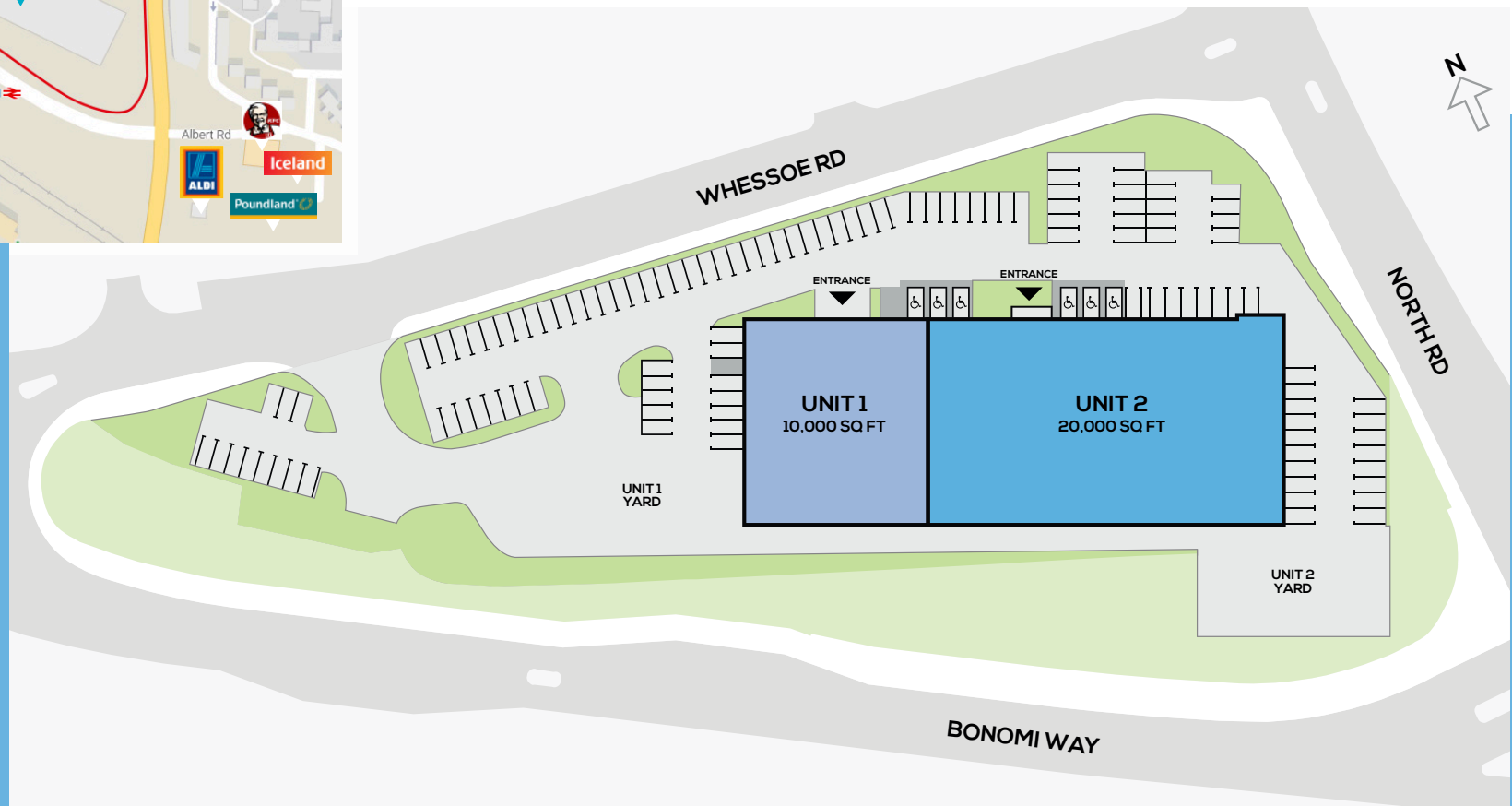
The property is prominently situated at the new junction on the A167, the main arterial route north of the town centre. The A167 carries circa 21,000 vehicles per day at this point.
